### Assessment

2. The closeness of any neighbours and businesses.
3. The views of the abutting neighbours (written consent forms will be required).
4. Proposed location and housing arrangements for the dogs on the property; and
5. The suitability of the property including fence height and construction.
6. The reasons for the application being made, including any supporting information.

### Assessment Criteria

These additional criteria must also be complied with;

1. All dog registration requirements must be satisfied;
2. All fencing requirements are satisfied;
3. The dogs are not used for breeding purposes;
4. The dogs are not of a restricted breed or declared a dangerous dog;
5. All abutting neighbours have provided written consent or have no substantiated reasons for refusal;
6. Payment of the prescribed fee of \$100, or \$23 for pensioner, has been received by the City of Stirling; and
7. There is no history or occurrence of dog nuisance or control that is likely to impact on the surrounding community.
