

Application – trading in thoroughfares and public places (event manager/organiser)

This application form must be completed by event organisers or market managers, to obtain an overarching permit to trade multiple stalls in any thoroughfare and or public place within the City of Stirling.

Ensure this application is submitted with the online event application (a minimum 8 weeks prior to the event).

Please note:

- This application applies to stalls that sell and/or hire goods (including food/drink) in public places such as
 footpaths, verges, roadways, reserves/parks and other public places (excludes Community and Recreation
 Centres) and includes buskers/street entertainers that are collecting money from the public for performances.
- This form is not required for private events on residential or private business properties.
- Local Law and City of Stirling Policy requirements are set out in the following documents and are available for viewing at www.stirling.wa.gov.au. Applicants are encouraged to read and understand the requirements contained in these documents prior to submitting an application: The Thoroughfares and Public Places Local Law 2009, Stallholders and Traders Permits in Thoroughfares Policy, Event Application Guidelines and Requirements.
- Permit fees may be applicable depending on the period and type of stall or trading being proposed.
- In some cases, depending on the nature and size of the operation, a Development Application may be required. If so, a processing period of a minimum of 12 weeks (84 days) prior to the commencement will be required. It is the Event Organiser's to ensure the required application is submitted in compliance with these timelines and process for Development Applications.
